Principal/School Report Tuesday April 12th

- Discuss the option of resuming commercial grade microwave usage with your SCC. We need to purchase some as we do not have any. They will not be located in the classrooms. The plan is to purchase 4-5 eventually. Two will be in the Home Ec. Room; two in middle years wing; one upstairs. Some schools are not bringing them back as they feel lunches have been healthier and microwaves can become an issue. "Warm-ups" only, not cooking from frozen to save time. Input from SCC?
- Staffing numbers have not been finalized yet for next year. (Only 6
 Kindergarten students though registered so far for the next year. We are
 looking at a teacher reduction, but nothing finalized).
- Class options for grades 10-12 including online courses will go out in May.
- Grad June 24th
- Online school supplies for K-grade 6 (option for families to purchase). Info will go out in May.
- Cash Online program we must use for tracking/paying fees (sports, PAA, etc.). Info goes out before the end of the year.
- EDSBY phone app. All families will have access next school year. Parents can report student absentees, see marks, communicate with teachers etc.
- The Division Showcase Track Meet will take place in June. We plan on hosting a pre-showcase meet with Norquay before the event. (K-6).
- Sr Basketball teams (with Norquay) Sr Girls finished 4th at Hoopla; Senior Boys finished 2nd.

- Senior Mixed Curling team reached Regionals.
- Badminton season is short and already winding down. Senior Districts are April 27th (Regionals and Provincials follow if players qualify); Junior Districts are May 5th. Teams entered tournaments in Yorkton, Kamsack, Canora, Invermay and Sturgis/Preeceville this season.
- Brad Cameron came in to do some NASP sessions with our grade 4-8 students. Nathan H. has been supporting the students as well. We will start noon hour practices after Easter break and run into May. There is a virtual shoot at the end of April. No in-person shoots this year.

- Mom's Pantry orders due on April 26th
- SRC just started looking into purchasing a van; hot dog machine (other items can be sold as well...tosquitos, smokies etc.) SCC thoughts?
